**COUNT I**  
**(18 U.S.C. § 844(i))**

On or about January 7, 2018, in the Central Division of the District of Utah,

BRIAN WINTERS,

defendant herein, did maliciously damage and destroy, or did attempt to damage and  
destroy, by means of fire and an explosive, real or personal property used in interstate  
and foreign commerce, to wit: an ATM machine located at the Goldenwest Credit Union,  
5639 West Highlands Loop Road, West Jordan, Utah; in violation of 18 U.S.C. § 844(i).

**COUNT II**

defendants herein, did maliciously damage and destroy, or did attempt to damage and

Union, 2089 West 9000 South, West Jordan, Utah; in violation of 18 U.S.C. § 844(i).

defendants herein, did maliciously damage and destroy, or did attempt to damage and destroy, by means of fire and an explosive, real or personal property used in interstate and foreign commerce, to wit: an ATM machine located at the Zions Bank, 12271 South 900 East, Draper, Utah; in violation of 18 U.S.C. § 844(i).
