I believe there is probable cause to charge the defendant with these charges because:

On April 14 2021 Logan City Police received this CyberTIp from The National Center for Missing and Exploited Children. The CyberTIp was submitted by SnapChat Inc, a popular messaging application. SnapChat advised user jfend3300 sent 47 images of suspected child pornography to other individuals. SnapChat provided an IP address associated with the account, which was being serviced by Comcast, as well as a email account.

I reviewed the 10 of the 47 images SnapChat provided. In the images were female children five to 12 years of age. All the children were in various stages of undress to include nude. There were no signs of development on the children's breasts or genitals.

With this information warrants were written for SnapChat (warrant number 2245191) and Google (warrant number 2245871). Both warrants were approved and signed by Judge Matthew Funk. A Subpoena was also written to Comcast for the subscriber using the IP address.

Google responded on April 23rd 2021. Google provided no information other then the account being created on March 5th 2021 and being deleted on March 8th 2021.

Comcast responded on April 30th 2021. Comcast indicated the subscriber using the IP address at that time belonged to Ivan Cardona. Comcast also provided the address and phone number for Ivan.

On May 27th 2021 SnapChat responded to the warrant. SnapChat only provided IP a few IP address associated with the account. One of the IP address came back to Nord VPN.

I found the address Ivan lives at is a rental. The rental was currently being rented to him and three other individuals. Over the course of several weeks, I drove past the residence during different times of the day. I was able to identify all the individuals living at the residence.

On July 12th 2021 I applied for a residence search warrant for the residence for any and all electronic devices. Warrant 2286781 was signed and approved by Judge Angela Fonnesbeck.

On July 14th 2021 the warrant was served. All electronic devices to include computes and mass storage devices were searched on scene. Ivan and another roommates phone was taken to be forensically downloaded.

The download of Ivan's phone showed over 16,000 pornographic images. Out of the 16,000 images most were of children. I also found Ivan recently downloaded Nord VPN to his cell phone. I reviewed 10 of the pornographic files.

In the 10 files were children ranging from 18months- six years old being anally raped by adult men. Some of the children were being digitally raped by adult men and other vaginally raped by adult men.

During the search of the residence a THC vape pen was located in Ivan's room. Also found in the room were five firearms, to include rifles, shotgun and a handgun. A separate warrant (warrant number 2287851) was drafted to seize the firearms, drugs a urine test from Ivan as well as to continue searching for more firearms and drugs.

No pornographic images were located in any of the other roommates electronic devices.

Ivan was taken into custody. While transporting him to Logan City Police Department, Ivan stated he has a problem with child pornography. Ivan stated he has anxiety as well as social issues. Ivan stated he knew it was

wrong but could not stop. Ivan admitted to view child pornography on the dark web as well as getting images from SnapChat. Ivan stated he would view the images and videos and then delete them. Ivan stated he would do this on his phone because he felt it was safer.

Of note, Ivan is also a special ed teacher at a local charter high school.

While at Logan City Police Department, Ivan completed a urine test which showed positive from THC.

Ivan was booked on appropriate charges.
